#### Conservation Plan

- JS provided an update on her work on co-occurrences. She indicated that she is now working on enabling the data and map for our conserved lands. We would like to overlay that with the other wildlife overlays to create our revised co-occurrences. One goal would be to produce a data table that would enable prioritization of the co-occurrence areas.
- KB indicated that she was still planning on working on the conservation portion of the town's Master Plan.
- Action: JS to continue to work on creating our co-occurrences and adding in the conservation lands overlay.
- Action: GT to add the management of our Conservation Plan to our By-laws. (From Feb meeting)
- o Action: KB to work with and update the Conservation Portion of the town's Master Plan.

### • Land Protection

- Intents to Cut
  - Follow-up 22-001-22; 1/30/23 Route 123A-Miller; Map 255 lot 2.1; map 256 lot 1; 70 acre lots; 50 acreas to cut.
    - Both lots are 100% in a region of highest ranked habitat in NH; Erosion concerns as well
    - General consensus was that this work began a few months ago and past the point of being able to address any concerns.
    - The commission agreed that in the future if we have concerns like this that the commission chairperson should contact the forester and/or landowner to ensure that they are aware of the conservation value of the land.
    - We also agreed that we need to have a handout or some educational information that
      we can put out to the town to encourage them to think about conservation impacts as
      they manage their private properties.
