# **APPLICATIONS AND GUESTS:**

1. Greg Bascom: Merger of previously subdivided lots. There was discussion regarding the Roy Farm property conservation easement. Motion FE/RL, passed, to cite the following:

This is the phrase in question in the Easement Document:

E. (On Page 4) Grantor reserves the right to subdivide the Property no more that two (2) times for the purpose of creating three (3) lots.

The key point in the Easement wording above is not the times the land is subdivided but the number of lots eventually created as long as no more than three (3) lots are created.

Under normal circumstances, in order to create three (3) lots from one, two subdivisions are necessary. The above paragraph does not take into account mergers of already subdivided properties. Once two (2) or three (3) properties within this easement are merged, the Planning Board is of the opinion that the merged lots could be subdivided again as long as they never subdivide to more than three (3) lots.

2. Driveway permit application, Goodell, Cold Pond Road: MA and RV viewed site. Motion RV/JN to approve contingent on applicant following State guidelines for culvert installation, passed.
