

**TOWN OF ACWORTH DEMOLITION PERMIT APPLICATION** Per Acworth Zoning Ordinance Article XI, Paragraph B: It shall be unlawful to erect or relocate any dwelling, building or structure or alter the bulk of any dwelling, building or structure without first obtaining a permit from the Board of Selectmen.

Although the Town of Acworth has not adopted a local building code ordinance, owners and contractors **MUST** still comply with New Hampshire building and fire code's minimum requirements per [RSA XII 155-A:2 I and VII](#). Demolition of structures shall comply with the State of NH Department of Environmental Services for asbestos abatement [Env-A 1800](#).

6. **ASBESTOS ABATEMENT:** The applicant shall submit to (NHDES) Department of Environmental Services a written verification from a certified NH [Asbestos Inspector](#) that the presence of asbestos-containing materials is absent or have been removed, according to ENV-A 1800 which regulates asbestos management in the State of New Hampshire and requires an asbestos inspection be conducted prior to renovations or demolition activities. Provide verification of "NHDES Notification" with your application. Notify the [Health Officer](#) 10 days prior to demolition unless by owner.

7. **LEAD PAINT:** Does the area of demolition contain materials that were painted, stained, or varnished prior to 1978? Y\_\_\_N\_\_\_ *If yes, lead safe work practices must be followed per US EPA.*

8. **SEPTIC TANK:** Per [RSA X 147:1](#) and [RSA X 147:10](#) the septic tank must be pumped by a licensed hauler to remove sewage, and the system needs to be inspected. NHDES considers septic systems a public health risk that must be addressed prior to demolition. Pumping removes waste, preventing accidental sewage spills during excavation.

Protected shoreland applies to lakes and ponds greater than 10 acres, 4th order streams and rivers, and other designated river protection areas. It includes restrictions and limitations on digging, building, use of fertilizer & herbicides, erosion, siltation, removing trees, vegetation, stumps and rocks as well as limits on % of impervious surfaces (e.g. roofs).
