- Notes: Lake Sunapee Protective Association (LSPA) "Let's Be Clear" Campaign Overview 14 Dec 22
 - Kirk Bishop provided an overview of the program.
 - Program focuses on the watershed for Lake Sunapee but the findings and recommendations would apply to any area in the U.S.
 - Kirk highlighted their research, education and collation efforts in establishing this program.
 - He stated that water quality has been declining. Gregg did research on our other water bodies and confirmed that the decline is in all our surface waters.
 - Kirk discussed the risks due to fertilizers, cleaning products, lack of proper erosion control, septic leakage, salt on roads and reduction of trees and vegetation.
 - He also talked about actions that everyone can take:
 - Phosphorous free fertilizers and cleaning products
 - Remove pet droppings within the 250' protective shoreline area
 - Maintain vegetation buffer along shorelines
 - Reduce salt usage on roads
 - Check septic systems every 3 years and resolve any issues timely
 - Farmers carefully manage the fertilization of crops that are close to perennial waters, ponds and lakes. Limit the risk of those products entering into the watershed sources. Also look for products that are less impactful.
 - Kirk also reviewed some actions that the town could consider:
 - Establish health regulations for septic inspections and repairs
 - Code enforcement of those regulations
