

## Conservation Plan

- Co-Occurrence Update
  - Janet presented two versions of co-occurrences using 4 map criteria (see below co-occurrence tables).
    - 1. Surface Water and Wetlands from GRANITView
    - 2. Significant State and Local Habitats from GRANITView
    - 3. Conserved and Town-owned Land from Conservation Commission 4/2023
    - 4. Locations of Rare and Endangered Species data source not yet identified; data provided by Janet's personal experience.
  - The 2<sup>nd</sup> version weighted the 4 aspects as follows:

1.	Local Significant Habitat	1x
2.	State Significant Habitat	2x
3.	Rare and Endangered Species	2x
4.	Conserved Land	2x
5.	Surface Water and Wetlands	4x

- Based on the discussion the commission agreed that the 2<sup>nd</sup> co-occurrence is closer to and accurate and meaningful assessment. We also agreed that this is also getting closer to enabling our prioritization of areas in town that we should focus our conservation efforts.
- We agree with Janet's suggestion to produce another version with more weight on the wetland and habitat criteria.




- Master Plan

  - Commission members agreed that we should also include the current objectives but we should allow those to develop with the progress we make with the development of the Conservation Plan.
  - Gregg to send out the goals based on the recent joint board presentation.

  - Gregg updated the Cold River portion with the description, location, monitoring, monitoring agencies and references.
  - Gregg will complete reordering this section to place watersheds at the top and list the components of the watershed and it's attributes. The key is the watershed.

## **Forestry and Conservation**

#### • Land Protection

- Intents to Cut We reviewed all 4 and did not have any reservations with the four proposed intents to cut.
  - 1. Sirkin-Gove Road, 201/145; 30 acres of 100; 35K MBF,60 tons of pulpwood; Leo Maslan logger
    - Habitat significance 0
    - 2 perennial surface water areas and 1 intermittent stream





- 2. Bascom-Duncan Road, 242/10; 15 acres of 78; 21MBF, 15 tons of pulpwood; 15 cords cordwood; David Bascom logger
- 3. Hoagland-Hoagland Road, 233/5&6; 3 acres of 73; 10 MBF, 85 tons of pulpwood, 15 cords cordwood; David Bascom logger
- 4. Richards-Old Stage Road 229/71; 17 acres of 18 acres; 81K MBF, 140 tons of pulpwood, 20 cord cordwood; John Hopkins logger.
  - Habitat ranked 0
  - Unknown assumed intermittent pond or wetland area.





- We did agree that if we do have a concern that we would follow the following steps:
  - Confirm concern with a ConCom resource if possible.
  - If we cannot confirm the concern, then a notification of concern be provided to the landowner as an offer for assistance.


- If we can confirm via visual or map resources that we have our forester (Peter Rhoades or Jeff Snitkin) confirm and proposed next steps with the Concom and Select Board.
- If a violation is in-progress, then a complaint to NH DES or NH Fish & Game will be initiated by the ConCom chairperson. NH Fish and Game if it is a time sensitive currently-occurring violation, NH DES if it is a continual violation.
- Building, excavation, and other permits None
  - Pierce Brook (Ernst) Property Pending request to swap parcels in and out of the conservation easement.
- Forestry complaints, concerns & other actions
  - Dodge Hollow Update Plan created; diagram with measures pending.
  - Perry Mountain Update See maps below.
- o Forester actions and plans pending plan schedule from our forester
- Surveyor action and plans talked with surveyor (Peabody) 3/7; update pending as of 5/8.
- Tree Warden actions and plans none
- o Easement Monitoring confirm 2023 assignments.

  - Update Prouty/Honey Brook Property Map 250 lot 2
- Water Protection (Crescent Lake, Cold River, watersheds, wetlands, ponds, and perennial streams)

  - Crescent Lake Water Quality Project NH DES, Crescent Lake Association, Natural Resources for Sullivan County, Unity, and Acworth Conservation Commissions; meetings on-going. Fair/forum being planned for 1 July; likely location will be the Unity Elementary School.
